Comparison between prescription of regular or on-demand Ibuprofen on postoperative pain after two visit retreatment of molar teeth

Protocol summary

Summary

Introduction: Pain management is very important in endodontic practice. The aim of this study is to compare the effect of pain relief of on-demand versus regular prescription of ibuprofen after two-visit retreatment in molar teeth. methods: seventy maxillary or mandibular molar teeth that need retreatment will have two-visit root canal retreatment. after this treatment, patients will be randomly allocated to 2 groups of 35 patients each. patients in group 1 will receive a single dose of 400 mg ibuprofen and a rescue bag of the same medication. patients in group 2 will receive the same medication as group 1 after treatment and they will be also provided with a prescription to use 400 mg ibuprofen every 6 hours for at least 24 hours. the patients will be asked to rate their pain on a visual analog scale for up to 48 hours after treatment.
