The effect of valerian, lemon balm and combined valerian-lemon balm oral capsules on severity of menopausal symptoms in women aged 45-60

Protocol summary

Summary

This study is a clinical trial designed to determine the effect of valerian, lemon balm oral capsules and their combined consumption on the symptoms of menopause in women aged 45-60. 120 healthy postmenopausal volunteers referred to Imam Khomeini clinic and Imam Hussein clinic (30 persons in each group) eligible of entry criteria (cessation of menstruation for at least 12 months due to menopause, no history of allergy to valerian, lemon balm, and their combination, etc.) were enrolled into the study after completing informed consent. Exclusion criteria were including any adverse effects during treatment including allergies to treatment capsules and no consumption of them to a maximum period of seven days or more per month of consumption, drug use, occurrence of any individual or family crises, and changes in diet and lifestyle such as changes to vegetarianism, health or addiction problems throughout research process. The subjects include three groups: treated with valerian, lemon balm, their combined form and the control group. The treatment group received 530 mg capsules of valerian (plant roots), or 250 mg Lemon Balm (plant leaves), or a combination of 160 mg valerian and 80 mg lemon balm, or 300 mg starch (controls) (capsules of the same form twice a day for eight weeks). The instruments of study consisted of demographic questionnaire, treatment registration forms and instrument of menopause evaluation criteria (physical, psychological and genitourinary dimensions) recorded and compared before treatment and then four and eight weeks after treatment.

Inclusion criteria: cessation of menstruation at least for 12 months due to menopause; no history of allergy to valerian, lemon balm and both of them; no history of drug use in the past two months, such as hormone replacement therapy and psychotic drugs etc. Exclusion Criteria: any kind of side effects during treatment such as allergy to valerian, lemon balm and both of them; no taking of oral capsules valerian, lemon balm and both of them for a maximum period of seven days or more during any month of consumption; using any kind of drug throughout the study; occurrence of any individual or family crisis during research process; any kind of change in diet and life style such as changing to vegetarianism diet during the research process; any health problems or addictions throughout research process.
